Subject- Addition in Qualifying Length of Service for Pension Fitment under Regulation 26 of Allahabad Bank (Employees) Pension Regulations. 1995

We invite your kind attention to our letter No. AIABPARA/2016-17/23 dated 13-10-2016 in the subject matter and await for your decision of honouring the court order in the matter & instruction circular for implementing the same.

It has come to our knowledge that the benefit of Regulation - 26 of Pension Regulations-1995, to add in qualifying service for fitment of pension to the eligible retired officers, has already been given Vijay Bank.

In this connection we wish to draw again, your kind attention towards the order dated 21-9-2016 by Hon'ble High Court of Allahabad Bench at Lucknow in Case No. 1160 of 2012 - Anand Pal Saxena & another Vs Union of India through Secy. Ministry of Finance, New Delhi. In this case the pensioners of Allahabad Bank were the Petitioners & the Petition has been allowed by the said Division Bench. (Copy of Judgment already sent with our letter dated 13-10-2016).

In case of eligible surviving 205 pensioners of our Bank, we have summarised the position as under based on the data of our pensioners that we have with us.



The pension payout to these 205 pensioners for the month of Oct- 2016 is estimated at approx. Rs. 63.63 lacs and on implementing the Reg-26 for these 205 pensioners the net increase of pension payout is estimated at Rs.5.97 lacs, which is very much affordable by our bank to meet the justice with all these specialist officers who served the Bank. As per records with us there are 15 family pensioners of this category, who may also be compensated by paying the arrears for the period from the date of their retirements. The list of such 205 pensioners is also attached herewith for your assessment and favourable order.

We therefore once again impress upon you to please consider the matter in the spirit of the court order favourably, and we request you to kindly arrange to issue instructions circular in this matter following the verdicts of the Hon'ble Court mentioned above.
